The Client agrees to be bound by all the following terms and conditions by submitting one or more payments in cash and/or debit/credit card to secure the requested reservation. ALL DATES ARE AVAILABLE UNTIL DEPOSITS ARE PAID IN FULL.

TERMS & CONDITIONS

By law you are not allowed to insure a car with more than one insurance company, therefore we cannot insure your car while it is under our care.

Garden Route Valet Parking. Valet parking is offered by Garden Route Valet Parking for the convenience of the Client and only for so long as the original time reserved by the Client.

The onus falls on you to let your insurance company know that your car is parked at our premises. Garden Route Valet Parking or any of its employees will not be held liable for any loss of or damage to property or held responsible for any injury or loss of life sustained.

For security reasons, we cannot disclose the address of our secure parking facility. Garden Route Valet Parking will under no circumstances be held responsible for any damage or loss to tyres or alloy wheels.

A cancellation fee will be payable to Garden Route Valet Parking if a booking is not honoured and it was not cancelled at least 12 hours in advanced.

If your vehicle's LOW FUEL light is on, we will put a R100.00 worth of fuel in which will be added to your bill. An additional service fee of R30 will be added to your bill as well. It is the client's responsibility to notify Garden Route Valet Parking of the time they will arrive at the George Airport, and we will not be held liable for any late delivery of the vehicles if not notified. By making a booking with Garden Route Valet Parking, the client acknowledges that he/she accept these terms and conditions.

We urge customers to make a note of their odometer reading, while transporting your car to our premises; we will never drive more than 40 km unless on your written instruction.

Payments by Client: The Client agrees to pay the balance, in full, to serve as a deposit to secure a reservation. Payments shall be made by Client at www.grvp.co.za or as per invoice.

Cancellation Policy: Reservations must be cancelled no later than 72 hours prior to the scheduled event.

Garden Route Valet Parking reserves the right to issue refunds at its own discretion contingent upon natural disaster, reasonable notice, circumstances out of the Client's control.

Movement of Vehicle: We may move and drive the vehicle between the Airport and our depot's for storage and/or car grooming services.

Items Left in Vehicle: Garden Route Valet Parking shall not be responsible for damage or loss to possessions or items left in the Client's vehicle or items in the vehicles of the Client's guests.

Damage to Vehicle: Garden Route Valet Parking holds liability insurance, but shall not be responsible for damage to Client's vehicle, whether or not such damage is caused by other vehicle(s) or person(s) in the parking lot and surrounding area.

Parking Lot Attendants: Garden Route Valet Parking provides parking lot attendants, also referred to as valets, to park vehicles. Use of such attendants by Garden Route Valet Parking to park or drive Client's vehicle shall be at the sole risk of Client.

Acceptance of Risk: Client agrees to assume responsibility for the risk of property damage while Client's vehicle is parked on the property provided by the client and/or parked by Garden Route Valet Parking's drivers.
